RAULAND-BORG CORPORATION OF FLORIDA (RBF) submits the following bid response for Winding Waters K-8 school's new classroom building project located in Hernando County, FL. This bid response is based on drawings prepared by Engineering Matrix sheets E-401 and E-402 dated 12/17/21.

This bid response is based upon Scope of Work: Section 27 55 00-Intercommunication System

Scope of Work: 27 55 00- Intercommunication System-Excluding Cable

- RBF's bid response includes IP modules, call buttons, hallway and classroom speakers and exterior horns per the specifications and drawings.

Installation Details:

- RBF will install the intercom field devices per construction drawings.
- RBF will test, program and connect the intercom field devices to the school's intercom system.
- RBF will require connections to the school's network (via a POE switch port).
- **RBF will use Cat 6 cable (installed and tested by others).**
- **RBF will use (2) strands of a fiber cable (installed and tested by others) from the MDF to the IDF in the new classroom building.**
- Bid response includes installation during normal business hours, Monday through Friday 7AM to 4PM. If after hours and/or weekend work is desired additional charges will apply.
- The electrical contractor must provide access throughout any inaccessible areas.

This bid response does not include:

- AC power, sleeves, fire stopping or caulking.
- Pathways including floor boxes and covers, backboxes, innerduct or conduit.
- **Cat 6 cable for the intercom devices.**
- **Fiber cable between the new and existing buildings.**
- Classroom clocks.
- Permitting costs. Once permitting costs are determined (if any) those will be billed under a separate invoice.
- Intercom equipment for future integration of a classroom Audio Enhancement System into the existing Rauland TCU intercom system. Additional intercom equipment will be needed if the system integration is possible.
