Sonsee Sanders, Director of Research & Accountability; Kerri Littlefield, Coordinator of MTSS; Brandon Wright, Assistant Principal; Isaiah Ilowit, School Physiologist; and Jason Keeler of Renaissance Learning came forward to present this item to the Board. Mrs. Sanders explained that this product was under the company Illuminate and it has since been acquired by Renaissance.

Ms. Duval asked if the information from previous years will be automatically uploaded into this product. Mr. Keeler stated yes, however the question is how much information do you need and how much do you want. They spoke about an example of tardiness. If a student is having an issue being tardy you can pull in their past tardy information.

Mrs. Rodriguez asked how eduClimber works with Skyward as the district has not implemented Skyward to its fullest capacity. Mrs. Sanders explained that they are very different products. She continued that Skyward houses data and in fact, many other

districts who use Skyward also uses a product like eduClimber. Mrs. Sanders listed some issues with the Skyward reports. Mrs. Rodriguez asked staff to look into opening up Skyward and implement the different components of it. She also mentioned her concerns with MTSS being part of the social and emotional learning curriculum. Mr. Stratton stated that MTSS is not for social and emotional learning, it is for intensive interventions. Mrs. Rodriguez also stated her concerns with disciplines being lost in the shuffle just to make the school look good. Mr. Stratton stated that if teachers are concerned with disciplines not being addressed or lost, then they need to get with their administrators.

Mr. Guadagnino asked if they knew how many hours will be saved as it was mentioned over and over again that it will save time using this product? Ms. Littlefield stated that it would be a lot of time.
