

**AMENDMENT No.1 BETWEEN
HERNANDO COUNTY SCHOOL DISTRICT AND
Catapult Learning, LLC**

This AMENDMENT No.1 (“**Amendment**”) to the Educational Services Agreement between the parties dated August 1st, 2024 (the “**Agreement**”), by and between Catapult Learning, LLC (“**Catapult**”) and Hernando County School District (“**District**” or “**Charter**” or “**School**” in accordance with the Agreement), is effective as of August 1st, 2025 (“**Amendment Effective Date**”).

The Parties hereby agree to amend the following sections in the Agreement:

1. Section 1 is amended by extending the termination date to June 30, 2026.
2. Section 5 (a) Not To Exceed Amount is increased to \$294,675.07
3. Exhibit A is amended by including new funding amounts for each school.
