

AMENDMENT TO AGREEMENT FOR EDUCATIONAL STAFFING BETWEEN
THE SCHOOL BOARD OF HERNANDO COUNTY, FLORIDA
AND KELLY SERVICES, INC.

THIS AGREEMENT made as of the [28th] day of [May], 2026, between KELLY SERVICES, INC., ("Kelly") and THE SCHOOL BOARD OF HERNANDO COUNTY, FLORIDA ("Customer"), collectively referred to as "the Parties," which entered into an Agreement for Educational Staffing ("Agreement") on May 20, 2014, to provide education-related services and shall become effective on the date last executed by either of the parties and shall serve to modify the Agreement as set forth herein.

WHEREAS the Parties entered into the Agreement on May 20, 2014.

WHEREAS, pursuant to the Agreement, Kelly provides education-related services under the Hernando County School Board's Supervision.

WHEREAS the Parties have a common desire to amend the Agreement to establish the responsibilities of Assigned Employees for Customer-issued equipment.

NOW THEREFORE, for good and valuable consideration, the Parties have mutually agreed to modify the terms of the Agreements, to include provision (n) under Paragraph 3, "Kelly's Responsibilities":

Direct all Assigned Employees to acknowledge in writing their responsibility for any Customer-issued equipment, including keys, badges, devices, and any other access tools entrusted to them. Each Assigned Employee shall acknowledge receipt, to safeguard such property, and to return all items immediately upon demand or at the conclusion of the assignment. Failure to return keys or other access devices imposes direct costs on the Customer, including but not limited to rekeying, replacement hardware, labor, security measures, and administrative processing. Customer will invoice Kelly for fifty percent (50%) of the cost of each replacement key. Kelly agrees to be liable for an amount not to exceed three hundred dollars (\$300) per the replacement key, with such liability limited to a maximum of five (5) keys per school year. Kelly shall remit payment to the Customer in full within 30 (thirty) days of the date of Customer's invoice.

IN WITNESS WHEREOF, the parties, by the execution of this Amendment by their authorized representatives below, bind themselves to all terms of this Amendment to the original Agreement.
